**Base Fee = \$250**

**1st Floor** up to 10,000 sq ft = square feet x .03 | **1st Floor** over 10,000 sq ft = square feet x .05

**2nd floor** = square feet x .10

**3rd floor** = square feet x .15

**4th floor** = square feet x .20

**Each Additional floor** = square feet x .20
